DOSAGE AND USE:

PERMEX 22E® must be mixed with water when used, at the ratio of 0.3-1% (30-100 ml for 10 L water) according to the pest extent.

One litre of this solution is suitable for 10-15 sqm surface and can be used with any type of standard sprayer: manual pressure pumps, motorised atomisers.

STATUTORY CONDITIONS OF APPROVAL RELATING TO USE

FOR USE ONLY AS AN INSECTICIDE. FOR USE ONLY BY PROFESSIONAL OPERATORS.

Dilute 30-100ml of product with 10 litres of water. 1 litre of diluted product will treat an area of 10-15 square metres. 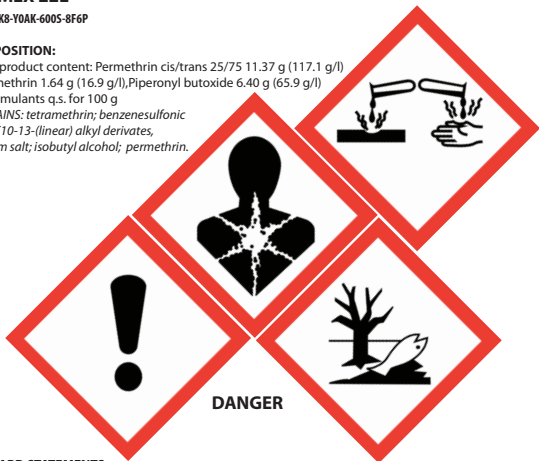

Tetramethrin 1.64 g (16.9 g/l), Piperonyl butoxide 6.40 g (65.9 g/l)

CONTAINS: tetramethrin; benzenesulfonic acid, C10-13-(linear) alkyl derivatives, calcium salt; isobutyl alcohol; permethrin.
